WMS truly believes that classical music is for everyone and through that expression we continually are inspired to find new ways to connect to our community.

WMS also has a Children's Choir that provides training and performance experience to school-aged children throughout the Lakeshore communities. The choir performs at WMS concerts and independent concerts in the community.
